

KNOW ALL MEN BY THESE PRESENTS, that in consideration of the benefits accruing to us by reason of convenient access and the desirability of having the things hereinafter specified, placed in the location noted below, and in consideration of One Dollar (\$1.00) receipt of which is hereby acknowledged, do hereby give and grant unto the City of Miami Beach, Florida, its successors and assigns, the perpetual right and easement to construct a bridge across that body of water designated as Lake, and bounded within the limits of the northerly line produced westerly and the southerly line produced westerly of Hotel Place, (now 24 Street), as said Lake and Hotel Place, (now 24 Street), are shown on the Amended Map of the Ocean Front Property of the Miami Beach Improvement Company, recorded in Plat Book 5, Pages 7 and 8 of the Public Records of Dade County, Florida.


