## NOTICE OF TESTING OF THE TABULATING EQUIPMENT (LOGIC AND ACCURACY TEST) AND CANVASSING BOARD SCHEDULE FOR THE CITY OF MIAMI BEACH GENERAL AND SPECIAL ELECTIONS NOVEMBER 5, 2013

Pursuant to Florida Statute §101.5612, entitled "Testing of Tabulating Equipment," notice is hereby given of the time and location of the public pre-election test of the automatic tabulating equipment (Logic and Accuracy Test) for the November 5, 2013 Miami Beach General and Special Elections.

Pursuant to Florida Statute §102.141, notice is hereby given of the time and place during which the Miami-Dade County Canvassing Board (acting as the Canvassing Board for the City of Miami Beach) for the November 5, 2013 Miami Beach General and Special Elections will meet to canvass the absentee electors' ballots and provisional ballots.

The Miami-Dade County Canvassing Board will convene at the Office of the Supervisor of Elections, 2700 NW 87<sup>th</sup> Avenue, Doral, Florida. The Canvassing Board is convening on these dates in preparation to conduct the Miami Beach General and Special Elections and the Miami-Dade County Special Election to be held on November 5, 2013.
