SUBJECT: **File No. 2193 – 8421- 8427 Crespi Boulevard – CUP for a Mechanical Lifts Extension of Time**

The applicant, 8421 Crespi, LLC., is requesting a one (1) year Extension of Time to obtain a building permit for a previously issued Conditional Use Permit for the construction of a parking garage with a mechanical lift system as required parking for a new, 5-story multifamily residential building, pursuant to Chapter 118, Article IV of the City Code.

RECOMMENDATION

Approval of the (1) one-year Extension of Time.

ZONING / SITE DATA

Legal Description: Lots 2 and 3 of Block 9 of "BISCAYNE BEACH SUB", according to the plat thereof filed for record and recorded in Plat Book 44 at Page 67 of the Public Records of Miami-Dade County, Florida.

Zoning: RM-1, Residential Multifamily, low intensity

Lot Size: 12,650 SF (110x115)

Proposed FAR: 1.25 / 15,812 SF as represented by the applicant

Proposed Height: 45'-5" feet / 5 stories | 59'-0" to highest non-habitable projection

BACKGROUND

February 26, 2014 Approval of Conditional Use Permit (CUP) to build a parking garage with a mechanical lift system as required parking for a new, 5-story multifamily residential building.

THE PROJECT

The applicant proposes to build a new five-story residential building on two adjacent lots including 16 units, 26 parking spaces, and 5 boat slips.

STAFF ANALYSIS

Since the original approval of the application, no changes to the Land Development Regulations of the Miami Beach Code have been recommended or approved which would preclude the construction of this project if were proposed today.

A building permit (B1504906) was applied for on 06/19/15 and has been reviewed by the Planning Department one time. Multiple revisions to the building permit by other trades in the Building Department and the request from Public Works Department to raise the ground floor elevator lobby and parking to match future street sidewalk level have led to the time expiration. In light of the delays encountered in permitting the project, it is suggested that the request for an extension of time to ensure that the permitting process consummates would be appropriate.

STAFF RECOMMENDATIONS

In view of the foregoing analysis, staff recommends the request for an extension of time be approved for a period not to exceed one (1) year from the expiration of the original approval which expires on February 26, 2016, subject to the conditions enumerated in the attached Draft Order.

ORDER

The applicant, 8421 Crespi, LLC., filed an application with the Planning Director for a Conditional Use Permit.

The City of Miami Beach Planning Board makes the following FINDINGS OF FACT, based upon the evidence, information, testimony and materials presented at the public hearing and which are part of the record for this matter:

The applicant submitted information establishing, among other things, that additional time is required due to delays in the permitting process. The foregoing constitutes good cause for granting a one (1) year extension of time to the requirement that a Full Building Permit be obtained within eighteen (18) months of the original Conditional Use Permit Approval.

IT IS HEREBY ORDERED, based upon the foregoing finding of fact and the staff report and analysis, which is adopted herein, including the recommendation, that a one (1) year extension of time to obtain a full building permit (which one [1] year period shall run from the expiration date of the original approval, which is February 26, 2016) is granted for the above-referenced project conditioned upon the following, to which the applicant has agreed:

1. A full building permit, not a foundation or shell permit, for the project shall be obtained by February 26, 2017.
2. Construction shall commence and continue in accordance with the applicable Building Code.

3. This extension of time shall run concurrent with any other extensions of time that may be provided to the property owner as a result of actions of non-City authorities with jurisdiction over such matters.
4. Nothing in this order authorizes a violation of the City Code or other applicable law, nor allows a relaxation of any requirement or standard set forth in the City Code.
5. The Final Order is not severable, and if any provision or condition hereof is held void or unconstitutional in a final decision by a court of competent jurisdiction, the order shall be returned to the Board for reconsideration as to whether the order meets the criteria for approval absent the stricken provision or condition, and/or it is appropriate to modify the remaining conditions or impose new conditions.

No building permit may be issued unless and until all conditions of approval that must be satisfied prior to permit issuance as set forth in this Order and the Conditional Use Permit for the August 26, 2014 approval have been met. The issuance of Conditional Use Approval does not relieve the applicant from obtaining all other required Municipal, County and/or State reviews and permits, including final zoning approval. If adequate handicapped access is not provided on the Board-approved plans, this approval does not mean that such handicapped access is not required.

When requesting a building permit, the plans submitted to the Building Department for permit shall be consistent with the plans approved by the Board, modified in accordance with the conditions set forth in this Order.
